Approval of Updated Personnel Policy Manual – Employment of Relatives

Exec. Director Fullerton presented the following information:

As part of the ongoing evaluation of the Personnel Manual, staff would like the Board to consider removing subsection A. from 2.10 Employment of Relatives ("Anti-Nepotism").

Subsection A. states: "Work within the same department (for Department Directors) or same area (for Superintendents)". Staff understands that the current subsection could be causing the District to lose out on the opportunity to hire qualified staff for open positions. Therefore, staff is recommending the removal of this stipulation.

The Board received a redlined and clean copy of this recommendation for their consideration.

Resident, John Supplitt, stated that he understands that removing subsection A dilutes the strength of the policy and but also makes it easier to secure staff. He believes leaving subsection A intact keeps the Board above reproach. He encourages the Board to vote "no" on this recommendation and leave "two degrees of separation" in place with the policy.

Commissioner Nesvacil asked a question about the length of time that has passed since the policies implementation.
