Bulk Fertilizer Applications and Turf Products

Dir. Rea presented the three bids received, stating that the budget for the Fiscal Year 2021/2022 fertilizer products and contractual applications is \$44,000.

Green Slopes Tennis Courts Reconstruction Recommendation

Dir. Rea explained in the 2021/2022 capital budget, \$483,000 was budgeted to replace the existing Tennis Courts at Green Slopes Park. All existing courts are planned to be removed and the base reworked with underdrains being added to improve drainage. The replacement courts include two tennis courts and four pickle-ball courts to fit within the existing fence. New ADA accessible sidewalks and a service path leading down to the courts from the existing parking lot is also included. The base bid was broken out into two bid packages:

- 1. Site-Work
- 2. Paving

In addition to the base bid, the following two alternates were solicited:

- 1. Site Work: Sleeve and replace perimeter fence posts and existing rails and gates. (Recommended)
- 2. Paving: Add Geotextile (Reflective crack control) paving fabric between the binder and surface pavement. (not recommended)

The bid packages were reviewed by staff for accuracy. Staff is recommending alternate number 1 (fence improvements) and isn't recommending alternate number 2 (geotextile fabric). When combining the base and alternate bid, American Grading becomes the lowest qualified bidder for Site Work.

The combined bids total \$398,173 and are under budget. Staff recommends establishing a construction contingency of \$51,827 to address any unforeseen conditions. The combined bids and contingency total \$450,000. Staff will update the Board on the final expenses of the project upon completion.

Comr. Nesvacil moved, seconded by Vice President Gelinas to approve 1) the base bid and alternate 1 as submitted by American Grading, Schaumburg, IL. for a total of \$279,228, 2) the base bid as submitted by Accu-Paving, Broadview, IL. for a total of \$118,945, and 3) not to exceed project budget of \$450,000.

Playground Safety Surface Replacements

Dir. Rea stated that in the 2021/2022 capital budget, \$41,340 was budgeted to replace the accessible entry safety surfacing at three playgrounds located at: Rand-Berkley, Patriots, and Victory Parks. Eleven existing playgrounds utilize the Soft Tile safety surface system to provide access and fall protection. Some tiles are failing and repairs are necessary to improve the user experience and reduce safety hazards. Additional sites will be addressed in the future.

The base bid was for poured in place rubber with an alternate to use Perfect Turf "Perfect Play" in-lieu of the poured in place.

The bid packages were reviewed by staff for accuracy. Staff recommends approving alternate 1 as submitted by Perfect Turf for a total of \$61,340.

While over budget, the project addresses safety and accessibility concerns at three playgrounds. The soft tiles are curling and pose a tripping hazard to patrons, while possibly limiting access to others.

Capital funds are available to cover the additional expense of completing the project.

<u>Vice President Gelinas moved, seconded by Comr. Owen, to approve the alternate bid for Perfect Turf Perfect Play as submitted by Perfect Turf, Rolling Meadows, IL. for a total of \$61,340.</u>
