Financial Forecast

Dir. Myers presented the Financial Forecast, and mentioned that this will be maintained up until the end of the fiscal year, but it is not staff's intention to take this document into the 2021/22 fiscal year.

GOFA Budget Awards Presentation

Dir. Myers presented the Government Finance Officers Association's (GFOA) Distinguished Budget Presentation Award Certificate. The award represents a significant achievement for the agency and is the 19th time it has been received. In order to receive this award, the District has to meet nationally recognized guidelines in a policy document, financial planning, operations guide, and communication of the budget. All of the staff of the District and board members contribute to this award and everyone's efforts are greatly appreciated.

Toro 4000-D Mower Purchase

Dir. Rea reviewed the mower selected and explained the additional proposed equipment that is necessary to protect the operator from the elements, provide safe operation on the road, and mulching kit. The additional proposed equipment requested is \$5,001.23 over budget. The mower can be purchased through BidBuy, the State of Illinois eProcurement system.

VP Gelinas expressed concern for not budgeting for these add-ons is frustrating when trying to maintain a budget. VP Gelinas asked Staff to consider having a budget for these types of accessories in the future.
