Membership Fees

The fee structure of the AHPD Racquet Clubs consist of an Annual One-Time Payment option or a Monthly Dues option, depending on the payment choice of the member. **If a member cancels his or her membership and re-signs up, within one year of cancellation, a re-enrollment fee of \$150 will be charged upon renewal.**

Dues

AHPD Racquet Clubs may on an annual basis, increase the annual membership, monthly dues or joining fee imposes upon members by giving 30 days prior written notice of the change. Posting of the changes in conspicuous places in the club will constitute written notice for this purpose. Notice may also come in the form of an email. Long term agreements are not exempt from periodic dues adjustments. Changes shall become effective on the date specified in the notice.

Monthly Dues Automatic Withdrawal

Monthly dues are based on the type of membership chosen; dues are charged on a monthly basis and in advance. **Transfers occur on the last day of the month.**

Freezing a Membership – Maintaining a Membership without Penalty

Members may request that their membership be temporarily frozen according to the following restrictions:

- (a.) Freezing a membership will be honored for **medical reasons only** and with written notification from the physician prior to the next charge.
- (b.) Memberships may be frozen for a minimum of two months, not to exceed six months.
- (c.) Monthly dues will not be charged during the membership freeze.
- (d.) Upon return, a written notification from the physician with the exact dates of restriction.
- (e.) The club will retain possession of a member's identification card during the extent of the freeze.

Cancellation of Membership

Member(s) agrees not to cancel their membership within one year of the date on their membership application; this applies to all membership and payment options. The membership may be canceled after one year (12 months) with a **30 day written notice**, accompanied by the membership card, and sent to the club. **If a member cancels their membership prior to one year, an early cancellation fee of \$50 will be assessed to the member.** Monthly memberships will continue pass one year (12 months) until the member submits written notice.

Returned checks - Member will be charged a \$20.00 fee for any returned check.

Court Reservation/Cancellation

Members can reserve court time in-person or by phone up to seven days in advance. Reservations for court time may be cancelled a minimum of 24 hours in advance to avoid being charged. Members are responsible for court fees when cancellations are made less than 24 hours in advance and the court cannot be sold. "No Shows" will automatically be charged to the members account.

Additional Fees

Court fees are **NOT** included in the tennis membership fee (does not apply to Forest View Racquetball Unlimited). Guests must pay a daily fee to use the club and follow all Rules and Regulations based on the club. Locker Rentals are available with signed contract; member must provide their own lock.

Rules and Regulations

Member(s) shall comply with any and all rules and regulations of the AHPD Racquet Clubs. Members must be at least 16 years old to use the Forest View Racquet & Fitness Club fitness center. Amendments to the Terms & Conditions, Rules & Regulations or Policies & Procedures are subject to change when deemed necessary at the discretion of the district.
